# National Safe Digging Month and Beyond:

Making 2011 a Banner Year for 811 / BY KHRYSANNE KERR



CGA stakeholders recently completed the fourth annual National Safe Digging Month campaign, an initiative that brings damage prevention stakeholders together each April to promote the 811 safety message in one collective voice. As has been the case in the previous years, the 2011 NSDM campaign surpassed all CGA records for exposure, whether it was in the news, online or through a variety of innovative grassroots partnerships.

So much of this success is due to all stakeholders staying true to CGA's motto, "Damage Prevention is a Shared Responsibility." This was evident in the way many stakeholders shared their successful past campaigns or their ideas for new ones through conference calls, meetings and participating in case studies for the inaugural CGA Communications Plan, which is posted at www.call811.com/ campaign-materials.

Proof of this can be seen in how several programs that got their start in one organization spread nationwide in 2011. More stakeholders than ever promoted 811 in one of the simplest yet most effective ways – by hanging a 4' by 8' banner from a fence or wall that faces a busy road.

Another program that went national this year was the partnership among several stakeholder groups to promote 811 on fire station marquees. Additionally, many organizations decided to make NSDM the time of the year to encourage their employees to take a pledge to always call 811 before digging.

Media coverage continued to be a major driver of 811 exposure, with placements earned on Fox Sports Radio and ESPN's Around the Horn, and in USA Today, The Washington Post and more than 2,000 other media outlets across the country.

# Call Before You Dig

Don't dig unless you know, there is no reason to make risky assumptions about the location of underground utilities. April is Dig Safely Month as declared by Gov, Nathan Deal. Georgia is joined by several other states nationwide in this safety initiative. Safe digging saves lives, time, resources and money.

"Spring is the time many of us take on outdoor projects and home improvements. We need to remember that there can be danger just below our feet. That is the reason we need to call 811 before beginning any type of digging, whether we are planting petunias, installing a sprinkler system, fence posts, mail boxes or building a deck. Not making the free call to 811 could cause injury to yourself or family, it could create costly repair bills or it could cause service outage. It doesn't make you popular in your neighborhood to be the one who dug through the cable, phone, water, power or gas line causing inconveniences or potentially life threatening situations," according to Georgia 811's President and CEO, Claudette Campbell.

Commission Chairman Stan Wise added "We are pleased to join with Gov. Deal and all interested groups in promoting public awareness to prevent damages and personal injuries that may occur due to damage to the state's underground utility facilities. In addition, we work to prevent the interruption of utility service as well. Georgia has built a damage prevention program second to none in the nation since the passage of the Georgia Underground Facility Protection Act over a decade ago. For those states who do not currently have a damage prevention program, I would issue a challenge to follow Georgia's lead and begin such a program, it is the right thing to do."

One call to Georgia 811 begins an important communication process to member utility companies who have service in the area of your project. "The smart and safe way to dig is to call 811 before every project, every time. It not only saves lives, but money and time. If you have dug in the past without calling, don't make that mistake again. The call is free and having the underground utilities marked is free," explains Campbell. In April of 2010, Georgia 811 took 81,042 requests to have underground utility lines located. For each request, an average of eight member utility companies were notified that digging would be taking place in their service area.

Danny McGriff, Director, Facilities Protection Unit, with the Georgia Public Commission Service "homeowners, reminds. landscapers, fence installers, farmers, plumbers, professional excavators anyone who will be digging- is required to dial 811 before beginning the project. Utility services like phone, gas, power, water and cable that your family depends on are buried underground. Every digging project requires a call to 811 - even small projects like planting trees or shrubs. Striking a single line can result in harm to yourself or someone else, costly fines and repair fees or inconvenient outages. One utility line is unintentionally struck every minute in the US. 811 is easy to remember and the call and the service are free. It also keeps you in compliance with the Georgia "Dig

A free call to 811 begins the process of getting underground utility lines marked. Georgia 811 notifies member utility companies where and when you plan to dig. These member companies dispatch locate technicians to mark the underground lines with colored paint and/or flags. By respecting the location of the paint marks and flags you can avoid dangerous contact with underground facilities.

Notify Georgia 811 at least two business days before excavation begins on public and private property, rights of way and easements. Know what's below. Call before you dig. Simply dial 811.





# Before digging, call 811 to find buried lines

Gardeners and do-it-yourselfers are making the sparks fly, and the nation's utilities want them to stop.

Residential customers have been blamed for most of the damage done each year to buried gas and electrical lines, something that could have been prevented by phoning ahead for the lines' locations, officials said.

"About 70,000 incidents were reported in 2009 where people didn't call '811' before they did any digging," said Bob Kipp, president of Common Ground Alliance (CGA), an industry-backed damage prevention group. "Somewhere between

40,000 to 50,000 of those know definitely can hurt you. were caused by homeowners - people trying to put in a new fence, patio, maybe some shrubs or a mailbox."

The nationwide 811 line alerts utilities about proposed construction projects. They can respond by sending crews to locate and mark the service lines.

An estimated 100 billion feet of gas, electric, water, sewer and communications lines are routed underground in the United States. At least half of all homeowners planning to dig on their property this year will do so without knowing where those potentially dangerous corridors run, according to a recent CGA survey.

In this case, what you don't

Take the case of the Muskegon, Mich., man who ruptured a gas line in April while uprooting a tree stump from his yard. "The homeowner called in the leak while standing nearby using his cell phone," said Maureen McCaffrey, an operations analyst with DTE Energy Co. in Detroit. "That could have sparked a fire or explosion with static electricity. The tab for that incident was just over \$1,600."

Every state has a one-call law, requiring that you check with a utility before doing any digging.

"The rules are similar, although enforcement varies dramatically state to state," Kipp said.

## Digger Dog teaches underground utilities safety

Area residents may find more time to do yard work or home renovations during the long summer months. Children, too, may have more time to dig around outside of their designated sandboxes.

Residents are being encouraged, however, to contact Georgia 811 for guidance on digging to keep safe. Georgia 811 is a non-profit corporation which functions as a communication system among utility companies, professional excavators, and homeowners in order to prevent damage to the state's underground utilities.

To see that goal through, the non-profit also promotes public safety and awareness of underground utilities, according to Georgia 811 Liaison Manager Megan Estes.

Georgia 811's mascot, Digger Dog, recently visited Unity Grove Elementary School in Locust Grove to encourage second-graders to "know what's below and call before they dig."

Estes said the mascot explained to the students the importance of not damaging underground utility lines by digging safely, how to be safe near overhead power lines, and what to do if the power lines are down.

The liaison said the students discussed what the small color-coded flags and lines of spray paint on the ground

represent, and how important it is that only authorized people move the flags. Students also experienced a


demonstration on what they should do if they smell natural gas.

The non-profit's web site states that, by law, contractors and homeowners must contact Georgia 811 at leas 48 hours before beginning any mechanized digging on properties.



The Commission works to educate excavators and utilities in order to avoid accidents that can cause expensive and often dangerous damage to buried utilities.


Commission Chairman Stan Wise said, "We are joining the Governor and all interested groups in working together toward a common goal to prevent damages and personal injuries from occurring to the state's underground utility facilities. In addition, we work to prevent the interruption of utility service as well. Since the passage of the Georgia Utility Facility Protection Act in 2000, the state has built a damage prevention program second to none in the nation."


"Excavators are only as good as the marks on the ground," said Commissioner Tim Echols. "That is why calling before you dig is so important."

Commissioner Lauren "Bubba" McDonald, Jr. added, "For those states who do not currently have a damage prevention program, I would issue a challenge to follow Georgia's lead and begin such a program, it is the right thing to do."

The Commission works in close cooperation with Georgia 811 which accepts calls from the national federally mandated "Call before You Dig" Number 8-1-1. This "one call" system is free to contractors and excavators as well as homeowners and helps all excavators comply with the law.





The Monroe visit was another stop in Echol's tour of the state, during which he is also promoting the use of stickers telling construction and utility crews to dial 811 before digging.

It was put into use officially in May 2007. Calling 1-800-282-7411 will still connect you with the Utilities Protection Center, Inc., d/b/a Georgia 811.

#### Who should call 811?

 Everyone who plans to dig! Do-it-yourselfers, homeowners, landscapers and contractors need to call prior to all digging projects — large or small. In Georgia, it is the law.

#### Why should people call 811?

The biggest reason is safety. Ensuring that the approximate location of underground utility lines are clearly

Within a few days of your call your underground cables and pipes will be marked for you.

# **CSRA Has Three Gas Leaks in A 24-Hour Time**

Augusta, GA --

In the span of 24 hours, there have been three <u>gas main breaks</u> in the CSRA caused by construction crews. Some led to road closures, others to homes being evacuated. There were two in Columbia County Tuesday night; one on the 5000 of Wrightsboro Road, and the other off of <u>William Few</u> Parkway, where six homes had to be evacuated. But, the <u>most recent gas leak</u> happened Wednesday morning in downtown <u>Augusta</u> on Broad Street between 4th and 6th Streets. It's the second <u>gas line</u> that was struck in downtown in the last two weeks.

Wednesday evening, traffic was flowing normal at the corner of Broad and 5th Streets.

Earlier in the day, cars came to halt when workers struck a <u>gas main line trying</u> to install traffic signals and street lights.

"It was marked, but it was marked incorrectly," said <u>Project Manager Scott Suttles</u>. "It was four feet off the mark, where we accidently damaged the line. Again, trying to keep the public safe, that's our first intent. Once we damage a line like this keep the public and pedestrians safe."

Luckily, nobody was hurt as a result of this gas leak.

"We can't be missing these types of markings," said Augusta <u>Commissioner Matt Aitken</u>. "When you have to evacuate people, <u>gas leaks</u> are very, very, very dangerous. We want to

p<u>rotocol</u> that insures we're doing our jobs right." But, in a statement by Atlanta Gas Light, it reads:

"All incidents involve 3rd party contractors accidentally hitting our lines. Emergency response crews were sent to the areas to secure the scene, shut the gas off and make repairs."

And, before anyone begins a project that requires digging into the ground - whether it's you at home, or a <u>separate contractor</u> - it is the law to call <u>Georgia</u> 811 before you do anything.

"There really aren't a lot of good reasons to make risky assumptions about where your <u>underground utilities</u> are," said <u>Georgia 811</u> <u>spokeswoman</u>, <u>Meghan Chesnutt</u>.

And, while the city continues to figure out what went wrong Wednesday, city officials say <u>gas leaks</u> in the town is one of their main concerns.

"A lot of us look at crime, but I think when you look at <u>gas leaks</u> or hazardous material leaks, I think we got to look at that across the board whatever may affect our citizens," said <u>Commissioner Aitken</u>. "We definitely want to make sure that we're on top of that."

<u>Commissioner Aitken</u> has asked <u>Augusta Fire Chief Howard Willis</u> for a report on what happened with Wednesday's break in downtown.




